How to Register:

Registrations are conducted Monday through Friday between 9:00 a.m. and 4:00 p.m.

Please allow for approximately 30 minutes per inspection. It is best to call ahead to ensure someone is available.

Items to Bring:

In order to complete the Special Purpose Vehicle registration process, you will need to bring the following items with you at the time of the inspection:

- Completed SPV Application.
- SPV needing to be inspected.
- Certificate of Title/Bill of Sale showing ownership.
- Proof of Insurance for SPV.
 - A copy will be kept on file.
- Valid Driver's License.
 - o A copy will be kept on file.
- Payment for Registration
 - Cash(exact change only), check, or money order made out to:

Special Purpose Vehicles (SPV)



A "How To" guide for registration.

Registration of Special Purpose Vehicles:

The City of Caldwell Ordinance Number 1475 makes it legal to operate a Special Purpose Vehicle, also known as a SPV, on the streets of Caldwell from sunrise to sunset provided the SPV is registered with the City of Caldwell.

A complete copy of ORD 1475 is available upon request from City Hall.

Registration Fee:

The registration fee is \$10.00 per SPV, per calendar year (January 1st through December 31st) and is due at the time of registration. This fee may be paid via cash (exact change only), check, or money order made payable to the City of Caldwell. All registration fees are due at the time of registration/inspection. Fees will NOT be prorated.

Definitions:

Special Purpose Vehicle

Are defined as golf cart, work-site utility vehicle, micro utility vehicle and all-terrain vehicle, either individually or collectively.

Slow-moving Vehicle Emblem

Is a triangular-shaped emblem of substantial construction having equal sides of 14 inches and an altitude of 12 inches, and such emblem shall be painted a fluorescent yellow-orange color and bordered with reflective red colored strips having a minimum width of 1 34 inches, with the vertices of the overall triangle truncated in such a manner that the remaining altitude shall be at least 14 inches.

A complete copy of ORD 1475 detailing the definitions of SPVs in their entirety is available upon request from City Hall.

FAQ

Q: Is a valid driver's license required to operate a SPV in the City of Caldwell?

A: YES. No person shall operate a SPV on any public highway, street, road or alley within the corporate limits of the city unless such person has a valid driver's license.

Q: Am I able to operate my golf cart night?

A: NO. A golf cart shall be operated on any public highway, street, road or alley only during the hours between sunrise and sunset.

Q: Am I required to display a slow moving vehicle emblem on my SPV?

A: YES. Golf carts and Work-site utility vehicles are required to display a slow moving emblem in order to operate within the city limits.

Q: Can my Work-site utility vehicle, or All-terrain Vehicle be operated at night?

A: YES. However, in order to do so your vehicle would need to be equipped with lights as required by law for motorcycles. If the vehicle is not equipped with these lights, then it can only be operated between sunrise and sunset.
